- Virtual Tutoring Program wrapped up on June 20th; still awaiting confirmation if funding received to run again in the fall term. Impact report in 2022-2023: Reached 830 students / 922 Volunteer Tutors / 6,108 Hours of volunteer tutoring provided. Approximately 51% of families were not CPF members previously.
- Meeting June, 20222, held with Diane Roy and Alain Dupuis of FCFA, with Derrek Bentley in attendance, at Forum des leaders on supporting CPF in building increased advocacy capacity.
 FCFA will follow up with a letter of support for our request for additional strategic funds.
- CPF will have two exhibitor booths at the ACPI Conference, in Ottawa in November 2022. One for CPF National to share with CPF Ontario; and one for the 'My Raison d'etre' FSL Teacher R and R Public Awareness Campaign. The last photoshoot will take place, with teachers attending the conference from Alberta, Manitoba, and Quebec. To complete the pan-Canadian representation for the campaign. We will host a dinner with the PRIX Idello National FSL Teacher Award winners 2020 (from Quebec) and 2021 (from Ontario). There may be an official announcement of the winner for 2022 TBC.
- CPF will host an exhibitor booth at the CASLT / OMLTA Conference, in Toronto in March 2023, providing, funding.
- CPF Staff and Volunteers completed 24 individual CPF FSL Stakeholder Meetings between April 27th and August 5th, 2022. New stakeholders reached: 10 (9 MPs and one senator). Reached 3 Cabinet Ministers: 6 Members of the Opposition (including one Bloc MP).
